### *THIS MONTH IN AMERICAN REVOLUTION HISTORY*

The Burning of Norfolk was an incident that occurred on January 1, 1776, during the American Revolutionary War. British Royal Navy ships in the harbor of Norfolk, Virginia, began shelling the town, and landing parties came ashore to burn specific properties. The town, whose significantly Tory (Loyalist) population had fled, was occupied by Whig (Revolutionary) forces from Virginia and North Carolina. Although these forces worked to drive off the landing parties, they did nothing to impede the progress of the flames, and began burning and looting Tory properties.

**Old Business:**

- Secretary Dan Evans again requested entries for the Patriot of the Month submissions, pointing out that the biographies that are submitted will also be put into the Patriot Research System of the National SAR. Compatriot Evans will give the presentation on his Patriot in February.
- Historian / Registrar Dennis Hahn reported that Chapter Compatriot / Missouri Representative Adam Schnelting was re-introducing to the Missouri House of Representatives House Bill 1464, which proposes:
  - The portion of State Highway 94 from State Highway TT to State Highway F in St. Charles County shall be designated as "George Washington Highway".
  - The portion of State Highway F from State Highway 94 continuing west to Femme Osage Creek Road in St. Charles County shall be designated as "Daniel Boone Highway".
  - The portion of State Highway K from Drennon Parkway to Technology Drive in St. Charles County shall be designated as "Major General Samuel Wells Memorial Highway".
