THIS MONTH IN THE REVOLUTIONARY WAR

On December 14, 1774, local Patriots from the Portsmouth area, led by John Langdon, stormed the post (overcoming a six-man caretaker detachment) and seized the garrison's powder, which was distributed through several New Hampshire towns for potential use in the looming struggle against Great Britain. On December 15, 1774, patriots led by John Sullivan again raided the fort, this time seizing numerous cannon.

Kathleen Nadeau of the “Of the Creators Hand” shop, who completed the uniforms at the St. Charles Heritage Museum’s exhibit of the American Revolution in the West, gave a presentation.

FDLSAR President Jackson and Secretary Dan Evans were wearing her creations, President Jackson in a buckskin militia uniform and Secretary Evans wearing a regimental coat of the Orange County, New York Militia.

Kathy described many of her painstaking procedures in producing exacting period clothing and received a Certificate of Appreciation from FDLSAR for her creative genius and Patriot of the Month from SCDAR as well as the National DAR American Heritage Committee of Women in the Arts award by Joan Koechig.

Stephen J. Kling, Attorney and Historian, was awarded a Certificate of Appreciation from FDLSAR for his outstanding efforts. **Joan Koechig** reported that on a recent trip she had the opportunity to visit Cartagena Spain and spoke with their city executive regarding setting up a sister city relationship with St. Charles.



THE AMERICAN CREED

by William Tyler Page

Accepted by House of Representatives, April 3rd, 1918

I believe in the United States of America as a government of the people, by the people, for the people; whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign Nation of many sovereign States; a perfect Union, one and inseparable; established upon those principles of freedom, equality, justice and humanity for which American patriots sacrificed their lives and fortunes.

I therefore believe it is my duty to my country to love it; to support its Constitution; to obey its laws; to respect its Flag, and to defend it against all enemies.
